



LIMITED WARRANTY

The items of the used vehicle described below are hereby warranted by the undersigned dealer under normal use and service for a period of 24 Months after date hereon or before such vehicle has been driven 30,000 Miles whichever shall first occur, and we the undersigned dealer agree, if said vehicle is delivered to our place of business, during the above stated period, to make, with reasonable promptness, any repairs or replacements to the below listed item(s) which may be necessary to its good operating condition in accordance with its normal use and service at a cost to the buyer(s) named below, of not more than 100% of the normal charge for such labor and not more than 100% of the normal charge for such replacement parts.

****NOTE:** A \$500.00 deductible will apply after 12 Months or 15,000 Miles, whichever shall first occur.

ITEMS COVERED:

All internally lubricated parts contained only within the engine and transmission.

****Not to include hydraulic lifters or electrical components.***

In order to utilize this limited warranty, the oil and oil filter must be changed and documented every 3,000 Miles or 6 Months, whichever shall first occur. The buyer(s) will be required to provide documentation certifying that all regularly scheduled maintenance has been performed and the mileage at each maintenance event. All warranty work must be performed by The Auto Connection. The buyer will be responsible for their own transportation whilst the vehicle is being serviced, for any reason.

IMPORTANT

This warranty will be null and void if the required maintenance has not been performed and documented with dates and mileage or if the operator has allowed the engine to overheat.

This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

This warranty does not extend to towing, travel expenses, or to any repairs or replacements made necessary by misuse, negligence, or accident, or to any systems or parts not listed above.

THE DEALER MAKES NO OTHER WARRANTY OF ANY KIND, EXPRESSED OR IMPLIED. THE DEALER MAKES NO WARRANTY OF MERCHANTABILITY. THERE ARE NO OTHER WARRANTIES WHICH EXTEND BEYOND THAT WHICH IS DESCRIBED HEREIN.

Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

The dealer shall not be responsible or have any liability for any consequential damages, damages to property, damages for loss of use, loss of time, loss of profits or income, or any other incidental damages.

Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

All warranty repairs must be done through the dealer from whom the vehicle was purchased. In order to obtain repairs or replacements pursuant to this warranty, contact the dealer from whom the vehicle was purchased.
